



VOLUNTEER APPLICATION

The Sienna Associations have various volunteer opportunities. Examples include:

- **Community Services Foundation/Community Enhancement Fund Grant Advisory Committee**-responsible for considering requests for grant funding and making recommendations to the Boards on which grants will benefit the community as a whole (quarterly evening meetings)
- **Finance Advisory Committee**-responsible for providing expertise and recommendation to the Board on financial matters (meeting frequency varies)
- **Hearing Advisory Committee**-responsible for holding hearings for members related to deed restriction violations (monthly evening meetings/if necessary/typically 1st Wed)
- **Landscape Committee**-assists with landscape-related projects, yard of the month, lawn care information. (quarterly evening meetings)
- **Modifications Sub-Committee**-meets to approve/disapprove modifications, additions or alterations made on or to the residences/lots (monthly evening meetings/typically 3rd Wed)

The following minimum qualifications are required to be considered for a committee or task force:

- Membership on a committee/task force is restricted to members (homeowners) with the Sienna Associations (SCA/SRA)
- No paid staff of SRA can serve as a voting member in any committee/task force position.
- Spouses or adults living in the same residence cannot serve on the same committee/task force.
- No outstanding balance or deed restriction violations with SCA/SRA.
