AMENDED AND RESTATED EMAIL REGISTRATION POLICY

SIENNA PLANTATION COMMUNITY ASSOCIATION, INC.

This policy amends and restates the policy in the Community Manual in its entirety and the policy in the Community Manual is of no further force or effect.

Terms used but not defined in this policy will have the meaning subscribed to such terms in that certain <u>Sienna Plantation Amended and Restated Master Covenant (Sienna Plantation Community Association, Inc.)</u>, recorded in the Official Public Records of Fort Bend County, Texas, as amended from time to time (the "Covenant").

- 1. <u>Purpose</u>. The purpose of this Email Registration Policy is to facilitate proper notice of annual and special meetings of members of SPCAI pursuant to Section 209.0051(e) of the Texas Property Code.
- 2. <u>Email Registration</u>. Should the owner wish to receive any and all email notifications of annual and special meetings of members of SPCAI or open meetings of the Board of SPCAI, it is the owner's sole responsibility to register his/her email address with SPCAI and to continue to keep the registered email address updated and current with SPCAI. In order to register an email address, the owner must register his or her email address at www.siennanet.com. Owners are responsible for keeping an updated email address registered at this website.
- 3. <u>Failure to Register</u>. An owner may not receive email notification or communication of annual or special meetings of members of SPCAI should the owner fail to register his/her email address with SPCAI and/or properly and timely maintain an accurate email address with SPCAI. Correspondence to SPCAI and/or SPCAI's manager from an email address or by any method other than the method described in *Paragraph* 2 above will not be considered sufficient to register such email address with SPCAI.

4. <u>Amendment</u>. SPCAI may, from time to time, modify, amend, or supplement this Policy or any other rules regarding email registration.


