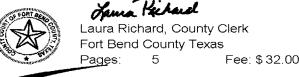

#### ENERGY SAVINGS DEVICES GUIDELINES/RULES

#### I. PURPOSE

The purpose of this Energy Savings Devices Guidelines/Rules ("Policy") is to assist owners in complying with the deed restrictions when installing energy savings devices on their property, as authorized by Texas Property Code Section 209.016.

## II. APPLICABILITY AND AUTHORITY

This Policy pertains to the following entities and encumbers that property restricted by the Covenant and the Declaration (defined below):

- 1. Sienna Plantation Community Association, Inc., sometimes doing business as Sienna Community Association ("SCA") as referenced in the Sienna Plantation Amended and Restated Master Covenant (Sienna Plantation Community Association, Inc.), recorded under Clerk's File No. 2019035843 in the Official Public Records of Fort Bend County, Texas ("Covenant"), as same has been or may be amended from time to time and any other property which has been or may be subsequently annexed thereto and made subject to the authority of SCA.
- 2. Sienna Plantation Residential Association, Inc., sometimes doing business as Sienna Residential Association ("SRA") as referenced in the Second Amended and Restated Declaration of Covenants, Conditions and Restrictions for Sienna Plantation (Sienna Plantation Residential Association, Inc.), recorded under Clerk's File No. 2012104699 in the Official Public Records of Fort Bend County, Texas ("Declaration"), as same has been or may be amended from time to time, and any other property which has been or may be subsequently annexed thereto and made subject to the authority of SRA.

Any reference in this Policy to "Board", "Boards", "Association" or "Associations" applies to all of the above-mentioned entities. Any reference in this Policy to "Sienna" collectively means that property encumbered by the Declaration and the Covenant.

Each Board is authorized by its respective dedicatory instruments to adopt policies pertaining to the governance of the Association that it serves. Invalidation of any one or more of the covenants, restrictions, conditions, or provisions contained in this Policy shall in no way affect any of the other covenants, restrictions, conditions, or provisions which shall remain in full force and effect.

#### III. GUIDELINES/RULES

## Solar Panels or Solar Collectors

- Roof Mounted solar panels must blend with the existing roof material. The frame, support brackets, and visible piping and wiring must be either silver, bronze, or black tone.
- Panels must conform to the slope of the roof and have a top edge that is parallel to the roofline. Solar panels and equipment must not exceed the height of the roof ridgeline.
   One rectangular, symmetrical and continuous panel is recommended.
- If more than one panel is used the additional panels must be installed continuously and must have no visible roofing material between panels.
- Panels should not travel over a valley, roof ridges, or vents.
- Feeder and return piping should penetrate the roof and be contained within the structure or be concealed by eaves or other structures.
- Solar Panels may also be placed on other flat surface structures such as a pergola or arbor provided all of the above criteria are met.
- Solar panels may also be placed in a fenced yard or patio provided that the height of the panels does not exceed the height of the fence surrounding the yard.
- Solar panels are not permitted:
  - That threaten the public health or safety of violate any law.
  - On any property owned or maintained by the Associations.
- The Modifications Sub-Committee (MSC) may deny any plans that do not meet these requirements of if the proposed solar installation constitutes a condition that substantially interferes with the use and enjoyment of land by causing unreasonable discomfort or annoyance to persons of ordinary sensibilities.
- Solar panels shall be located in the least visible area possible on the property unless
  the least visible location increases the estimated annual energy production of the
  devise, as determined by using a publically available modeling tool provided by the
  National Renewable Energy Laboratory, by more than 10 percent above the energy
  production of the device if located in an area designated by the Associations.

#### Roofing Materials

- The Associations will not prohibit or restrict the installation of the following roofing materials:
  - That are wind or hail resistant;
  - Which provide heating and cooling efficiencies greater than those provided by customary composite shingles; or
  - Provide solar generation capabilities; and when installed

- resemble the shingles used or otherwise are authorized for use within the Associations;
- > are more durable than and are of equal or superior quality to the shingles authorized for use within the Associations; and
- > match the aesthetics of the property surrounding the owner's property

## Wind Turbines

- Wind turbines should be mounted in the rear portion of the roof so that they are not visible from the front or above the roofline.
- The wind turbines should be painted to match the roof.

## Rainwater Harvesting Systems

- Rainwater Harvesting Systems must be placed in the rear yard of a home or in a side yard
  provided adequate screening is provided as determined by the Modifications Subcommittee
  The color of the barrel or system must be consistent with the color scheme of the home and
  shall not display any language or other content that is not typically displayed by such a barrel
  or system as it is manufactured.
- Only commercial and professional grade rainwater harvesting systems are permitted.
- All rainwater harvesting systems must be fully enclosed and have a proper screen or filter to prevent mosquito breeding and harboring.
- Rainwater Harvesting Systems should not create unsanitary conditions or be of nuisance to all neighboring properties.

### IV. SUBMITTAL REQUIREMENTS

A modifications application must be submitted for review by the MSC for all Energy Saving Devices listed. Formal approval from the committee will be required before installation may begin. The completed application must include a site plan and/or roof plan showing the proposed location of the improvement, along with pictures showing the location of the modification and the manufacturer's brochures or sample of material if applicable. Please note specific concerns of the committee will be the color of the materials being used in relation to the roof or house color and visibility from public streets, neighboring properties/common areas and any noise resonated. The MSC may in certain instances require neighbor consent forms from other owners in the general vicinity. Any installation not in compliance with these guidelines will be considered a deed restriction violation and will be dealt with accordingly.
