

VENDOR/CONCESSION SALES POLICY

Sienna Community Association Sienna Residential Association

I. PURPOSE

The purpose of this policy is to outline the guidelines for vendor/concession sales at Association facilities and vendor/concession sales as a part of Association community events.

II. APPLICABILITY AND AUTHORITY

This Policy pertains to the following entities and encumbers that property restricted by the Covenant, the Declaration (defined below):

- 1. Sienna Plantation Community Association, Inc., sometimes doing business as Sienna Community Association ("SCA") as referenced in the Sienna Plantation Amended and Restated Master Covenant (Sienna Plantation Community Association, Inc.), recorded under Clerk's File No. 2019035843 in the Official Public Records of Fort Bend County, Texas ("Covenant"), as same has been or may be amended from time to time and any other property which has been or may be subsequently annexed thereto and made subject to the authority of SCA.
- 2. Sienna Plantation Residential Association, Inc., sometimes doing business as Sienna Residential Association ("SRA") as referenced in the Second Amended and Restated Declaration of Covenants, Conditions and Restrictions for Sienna Plantation (Sienna Plantation Residential Association, Inc.), recorded under Clerk's File No. 2012104699 in the Official Public Records of Fort Bend County, Texas ("Declaration"), as same has been or may be amended from time to time, and any other property which has been or may be subsequently annexed thereto and made subject to the authority of SRA.

Any reference in this Policy to "Board", "Boards", "Association" or "Associations" applies to all of the above-mentioned entities. Any reference in this Policy to "Sienna" collectively means that property encumbered by the Declaration, and the Covenant.

Each Board is authorized by its respective dedicatory instruments to adopt policies pertaining to the governance of the Association that it serves. Invalidation of any one or more of the covenants, restrictions, conditions, or provisions contained in this Policy

shall in no way affect any of the other covenants, restrictions, conditions, or provisions which shall remain in full force and effect.

III. GUIDELINES

Sienna's facilities, and events provide residents with places to connect to the natural environment and to enjoy spending time with family and friends in a wide variety of ways. The Guidelines below outline vendor/concession sales at Sienna's facilities.

Concessionaires, vendors, or individuals are not permitted to sell merchandise or services, promote the sale of merchandise or services, or operate a concession on the Association's property or common areas unless they meet one of the exceptions below and have been approved by the Association.

1. Community/Special Events

Vendors/concessionaires may sell or solicit products or services at Association facilities in partnership with an authorized Sienna community event, and only with prior approval of or by invitation from the Association. In such cases, the vendor/concessionaire is a component of the event and is required to abide by all event organizer rules and regulations. Vendor/concessionaire agreements are with the Association and may, dependent on the event, require a participation fee to be paid by the vendor. In all cases, special events are defined as those sponsored or hosted by the Association. The Association may charge a fee for vendors/concessionaires, or organizations that sell products at an Association-related community/special events. Vendors/individuals that set up on Association common areas for non-Association related events, may be asked to leave the premises by an Association staff member.

2. Permits

Approved vendors/concessionaires are responsible for obtaining and maintaining all necessary county and state permits. Issued permits must be clearly displayed at the event and no vendor/concessionaire will be allowed to stay onsite or participate in an event, even if pre-approved, without the appropriate permit (county, health, etc.).

3. Vendor/Concessionaire Requests, Agreements, and Approvals

Any proposals for providing vendor/concessionaire services for an Association community event or at a facility must be submitted to Sienna Associations, 9600 Scanlan Trace, Missouri City, TX 77459, Attention: Community Relations Manager. Proposal must include the vendor/concessionaire name, contact information including the mailing address, telephone number and email address, as well as a description of the services. Approved vendors/concessionaires must provide a completed W9 prior to submittal of any invoice and/or payment.

Exceptions to this policy/guideline require the authorization of the Associations' General Manager and/or Board of Directors.
