2024 ELECTION PERIOD Opens October 7

The 2024 Village Representative (Village Rep) and Sienna Residential Association (SRA) Board of Directors election period opens on Monday, October 7, and contin-

ues through Tuesday, November 5. During this upcoming election period, property owners will elect Village Reps from within SRA (Anderson Springs, Avalon, Bees Creek, Shipman's Landing, Steep Bank East, Steep Bank West, and Waters Lake) and the Sienna Community Association (Sawmill Lake and Sienna Oaks). It is possible, that as nominations closed, there may be non-contested races, and therefore no Village-specific election will be necessary. In addition to electing Village Reps, property owners within SRA have the opportunity to elect two (2) SRA resident-Board of Director positions. The SRA Board is a five (5) member Board with three (3) of those positions appointed by the Developer.

Ballots/proxies along with voting instructions will be distributed to residents in October, via Election Trust. Election Trust, a third-party election service will be responsible for conducting the election process this year. This includes mailing ballots and instructions to residents and completing the tally of results. This is common practice for a Board member election year. Election results will be announced at the SCA/SRA Combined Annual Meeting on Tuesday, November 12.
