SRA - Bees Creek, Avalon, & Steep Bank East


The Association encourages all residents to take a few minutes and look over their property for any potential Deed Restriction issue that may result in a violation.

### HURRICANE AWARENESS



**Tree Evaluation:** The Associations' contracted horticulturists and tree consultants spend extended time in the spring prior to hurricane season evaluating trees within the common areas. Specifically, they look for damaged, sick or dying trees that may pose a hazard to surrounding areas or buildings and identify any that may need to be removed. Additionally, tree trimming teams may trim back trees that seem top-heavy or have overhanging limbs, that if damaged during a storm, could break and cause an issue on a walkway or path. Healthy trees, and those in reserves (and away from buildings or paths) are not removed due to height or large limbs.

**Emergency Preparedness Plan Review:** Each year, staff reviews and edits, as necessary, the Associations' Emergency Preparedness Plans including an internal plan which details step by step actions staff must take in advance of, and during a hurricane, as well as the external Emergency Preparedness Plan that is developed as a resident reference and is available online at Siennanet. This plan provides information and tips for residents in the event of a hurricane but also other disasters that could occur in our area.
